The Tender should be in a strong sealed cover marked as tender for the supply of Furniture. The last date of tender submission is 27-01-2018 before 4-00 pm at JNV Mudgal. The tender will be opened in the office of the Principal, JNV mudgal on 29-01-2018 at: 10:30 AM.
02. There should not be any over writing or correction in the Tender. If absolutely necessary it should be attested with full signature of the Tenderer.
03. The delivery should be made to the JNV mudgal at their own cost.
04. Rates quoted should include, packing, Transportation, loading & unloading etc,
05. The Quantity shown above may be increased / decreased at the time of placing order as per Requirement of the Vidyalaya.
06. Successful tenderer should supply the Furniture within 15 days from the date of receiving the supply order.
07. Tenderer should enclose the Demand Draft for Rs. 4600 /- as an EMD in favour of Principal JNV Mudgal, drawn on State Bank of India Mudgal.
08. For unsuccessful Tenderer EMD DD will be returned with in 10 days.
09. For successful Tenderer the EMD amount will be refunded after one month of supply. If there is no further order during the year.
10. Tenders which are not enclosed EMD amount will not be considered. Except the Government Agency/ Government approved Agency.
11. The undersigned does not bind himself to accept the lowest tender and reserves the right to accept/reject tender in whole or in part without assigning any reason there off.
12. The rates quoted are applicable till 31st March-2018.
13. The Tender forms are not transferable to any other supplier/firm.

14. The Tenderer should quote rate for all items given in the tender schedule in order.
15. In the event of acceptance of the tender and placing of the order for purchase the articles ordered for would be subjected to an inspection by the undersigned or his representative and are liable to be reject if the articles supplied are not according to approved samples or do not confirm to the specifications prescribed.
16. If the contractor fails to supply the furniture within the stipulated time. The undersigned shall be at liberty to purchase the Furniture from open market or from any agency.

FORM OF TENDER FOR THE SUPPLY OF FURNITURE.

S.No.	Particular with specification	Rate per Unit
01	STEEL SLOTTED ANGLE RACK (BIG) RC No. 007. : Size 1.80m H x 0.90m W x 0.375m D over all with 04 upright and 05 panels. The upright shall be slotted angle of section 40x40x02mm and the panels of six 900x375mx 20G, the panels should be fixed to the upright by means of GI bolts of sizes 8mm x 16mm by providing 16 No.s standard gussets at corners. The rack shall be painted as per indentors choice.	
02	'S' TYPE CONTINIOUS ARM CHAIRS: (RC.No.003(1)) :-With good quality teakwood frames for seat and back with polyurethane arms rest. The seat and back knitted with nylon cane. The seat fixed on with flat o brackets on four corners, seat and back frames are polished with colorless French polish (black enamel paints should be coated). Height 89Cm width 50.8cm depth 53.34 Cm. the iron frames should be of 25mm dia 16G steel tube should be properly bent to its required shape with rubber shoes at bottom. The frame joints should be neatly finished and spray painted with approved shade of enamel paint.	
03	STEEL ALMIRH Size 198cm H X 915cm W X48cm D (including leg of 15.24cm) fitted with four fixed shelves making 05 compartments double doors with three way locking device and duplicate keys, all joints outside and I inside should be spot or arc welded ad neatly finished by grinding. The outside corners should be rounded of to give good appearance. The edges of the doors and shelves should be properly bent to `u` shape of 25mm width to ensure good strength and the outer edge of `U` bent of the door length wise should be double folded and neatly finished. The shelves front side should bent to `U` shape neatly and finished to avoid any possible cuts to fingers and had when handled. Longitudinal rib of 15.24cm wide including bent to required shape should be provided and fixed to each door at its centre. The breadth of the shelves in the almirh should be to the entire width leaving about 12mm gap from shutter when it is closed.	

04	<p>JANATA TABLE Of size 0.91 L X 0.46 W X 0.75 H made out of 22G. MS sheets. The top shall be made out of 22mm laminated block board with PVC beading around. The bo shall be of size 0.43 D X 0.36m W with one drawer at the top and a locker with a shelf at the bottom with independent locking arrangement and necessary handles. The table shall be derusted, primer coated and painted with synthetic enamel paint as per indentors choice.</p>	
05	<p>DINING TABLE:Of size: 182 .88 cm L X 91.44cm B X 76.2cm H. for pedestal 6 No.s sq. pope has to be used i.e. 4 legs at the corners and 2 legs in the middles all the top and cross pipe shall be 16G cross pipe have to be welded all-round and in the middle at the bottom, top should be made of 20mm block board with lamination and with teak wood round beading all-round the legs to be provided with strong rubber shoes. The table frame should be derusted primer. Coated and spray painted with synthetic enamel paint as per indentor choice.</p>	
06	<p>BENCH FOR THE DINING TABLE Of size 182.88cm L X 30.48cm B X 45.72cm H with 06 legs and the legs and cross supports 2.54cm sq. pipe of 16G has to be used. Cross pipes have to be welded jointing all the 06 legs and 01 cross pipe in the middle. For top 20mm block board with lamination and teakwood beading all round to be used, the legs to be provided with strong rubber shoes, the bench frame should be derusted primer coated and spray painted with synthetic enamel paint as per indentor choice.</p>	
07	<p>DUAL DESKS AND BENCH:</p> <p>a) DESK: Front 76.2cm height, back 71.12cm height. The pedestal shall be sq. pipe of 16G x 2.54cm to be used. The desk top size 91.44xcm L x 36.83cm W. below the top a book shelf of size 91.44cm L x 24.13cm W to be fixed and the same should be covered all three side. The top and self should be 20mm thick block board with sun mica pasted. At the bottom of for both sides legs has to be joined with 2.54cm sq. pipe and in the middle of both the legs one cross pipe has to be welded to serve as a foot rest.</p> <p>b) BENCH: of size 91.44cm L x 30.48cm W x 66.45 H for legs sq. pipe of 16G x 2.54cm to be used, the height of sitting plank shell be 40.64cm from bottom and of size 91.44cm x 30.48cm block board with sunmica pasted. At the top 91.44cm L x 10.16cm B block board with 20mm thickness with sunmica pasted has to be fixed to serve as a back rest. Strong rubber bushes have to be fixed for legs. The pipe have to be painted with enamel paints as desired colour of the intendor the desk and bench has to be jointed to make it a unit using necessary corsss bars.</p>	
08	<p>ALMIRH WITH GLASS FOR LIBRARY :6.5 H x 36 W x 18 inch L fitted with five compartment double Glass door and duplicate key note the CRAC. Sheet of 20 G. body & sheet 4 mm Glass door.</p>
