**CIRCULAR**

In modification to earlier circular dated 20-12-2017 issued by the Samiti for revision of fees of Vidyalaya Vikas Nidhi in JNVs is indicated below:-

*"The Executive Committee in its meeting held on 31-8-2017 has considered the revision of fees for Vidyalaya Vikas Nidhi (VVN) to maintain the quality and upgrade the facility in schools from eligible categories like Government Servants. Hence EC approved the proposal to enhance the fee of Rs. 600/- from Rs. 200/- pm in respect of students excluding students from Class VI to VIII, SC/ST students, Girl students and those from BPL families. However, in case of students from the family of Govt. Servants, the VVN of Rs. 1500/- per student per month may be charged irrespective of their category."*
